DMV VEHICLE REGISTRATION SUSPENSIONS

The DMV may suspend a vehicle's registration due to a lapse in vehicle insurance coverage and/or rejected payment of registration fees.

In cases where DMV suspends registration, a notation will be added to a vehicle's registration information as follows: "VEH REG SUSPENDED EFF: MM/DD/YYYY."

When interpreting a vehicle's registration, the suspension date is functionally equivalent to expired registration. Please, note the "SUSPENDED" date is the new expiration date and it does not revert back to the original expiration date. The decision to tow a vehicle must be made based on the new registration suspension date.

Vehicle Registration Insurance Suspension

Vehicle registration suspended due to lapse of insurance and expired vehicle registration is functionally equivalent. The decision to tow a vehicle pursuant to Vehicle Code §22651(o) would be made at the law enforcement or authorized impounding agency's level. The Department of Motor Vehicles will support the interpretation that an agency is authorized to remove a vehicle for a registration that has been suspended for six months or more.

Note: The actual expiration date may still be current.
