FAMILY CODE SECTION 6306 AND VIOLATION OF FIREARM RELINQUISHMENT ORDERS

Family Code section 6306 requires that the Superior Court of California, County of Los Angeles (Court) report to law enforcement agencies when either or both of the following instances are met related to Family Code domestic violence matters:

- (1) When there is a domestic violence restraining order for a person with an outstanding warrant.
- (2) When there is a finding by the court that a restrained person has violated a firearm relinquishment order.

To comply with this statutory mandate, the Court has requested that El Segundo Police Department provided an email resource account to the Court, who will send a copy of the restraining order and a copy of the minute order if findings determining a violation of an order are made. The restraining order copy will be stamped with "Notice pursuant to Family Code 6306" on the face page to identify the reason ESPD is receiving the restraining order. Effective January 1, 2023, the Court will also use newly adopted form DV-830 (see below) to make such notifications.

The email containing the order will be sent to All Command Staff, who will then forward to appropriate personnel.
